POST-PANDEMIC OPPORTUNITIES TO FINANCE A SUSTAINABLE SOCIETY

Dr. Janis Sarra, Professor, Peter A. Allard School of Law, University of British Columbia, Vancouver, BC



Dr. Sarra's research and teaching interests are in the areas of corporate finance, banking law, corporate governance, securities law, contracts, commercial insolvency law, and law and economics. Dr. Janis Sarra was appointed UBC Presidential Distinguished Professor in 2014 for a five-year term. Dr. Sarra is Professor of Law, at the Peter A. Allard School of Law, was founding Director of the National Centre for Business Law and former director of the Wall Institute for Advanced Studies. She has published twelve books and more than one hundred refereed articles, and has been cited extensively by Canadian courts at the superior court and appellate levels. She is author of numerous reports on climate change, including: *Fiduciary Obligations in Business and Investment: Implications of Climate Change*, 2018 (CCLI, Oxford); *Time to Act*, Response to questions posed by the Expert Panel on Sustainable Finance on Fiduciary Obligation and Effective Climate-related Financial Disclosures, co-author with C. Williams, 2019; and *The Anthropocene in the Time of Trump, Financial Markets, Climate Change Risk and Vulnerability*, 2018. She is a member of the Canadian Delegation to the UN Commission on International Trade Law WG V.

Susan leads Hatch's global climate change and sustainable development practice with 20 years of experience in this field. Prior to joining AlphaFixe Capital, Simon worked as an Investment and Treasury Manager at Commission de la construction du Québec (CCQ), where he oversaw various external mandates. In addition, he was a member of the Sustainable Development Committee. Simon also worked at the Treasury of Desjardins Group as Credit Analyst.

Simon holds a Master's degree in Finance from Sherbrooke University and a Bachelor's degree in economics from UQAM. He also holds a Sustainable Investment Professional Certification from Concordia University.

Céline is an ambassador for women under the global [Equal by 30 Initiative](#). Her public service includes sitting as an independent director at [Green Centre Canada](#) and [Emissions Reduction Alberta](#), and chairing the Core Evaluation Team of [Genome Canada](#)'s Genomic Applications Partnership Program. Her leadership roles have included Chair of the Clean Technology Private Sector Advisory Group and senior advisor for Global Affairs Canada's Trade Commissioner Service. She is a senior associate at the International Institute for Sustainable Development (IISD) where she leads research on sustainable finance. As a past [senior fellow](#) at the Centre for International Governance Innovation she conducted research on innovation, infrastructure and served as co-chair of the Think Tank 20 (T20) [Climate Policy and Finance Task Force](#).

As the President of Analytica Advisors, in 2007 she recognized that innovation-based industries were poorly represented through existing primary economic research. In order to change this, she authored and published seven annual evidence-based national reports that have catalyzed the growth of Canada's emerging energy and water technology industry. Her research changed the investment and policy landscape, and has formed the basis of hundreds of millions of dollars in catalytic public investment.

Alison Schneider, Director of Responsible Investment, Alberta Investment Management Corporation (AIMCo), Edmonton



Alison, Director of Responsible Investing, joined AIMCo in 2011. AIMCo is consistently recognized as a top performer by UNPRI, as a Top 25 global asset allocator by New Americas (RAAI) and is a 2019 International Corporate Governance Network (ICGN) award finalist. Alison is a co-founder of GRESB Infrastructure, chairs its advisory board and co-chairs the Shareholder Responsibility committee at ICGN. She sits on committees for PRI, CCGG, PIAC, RealPAC, SASB, and the G7 Investor Leadership Network. Alison is a recipient of the Clean50 Award (2019), published author (*The New Frontiers of Sovereign Investment*, Columbia University Press, 2017) and co-author of an investor guidance on TCFD Implementation (2019); ICGN Guidance on Fiduciary Duty (2018) and Guidance on Diversity (2016). Alison regularly presents at business forums (ex. PRI, ICGN, Globe, IREI, FEI, CPA Canada) and for the Institute of Corporate Directors (ICD). Alison founded the Net Impact Edmonton professional chapter (2011), is past-president of the Junior League of Edmonton (2005) and taught board governance to NFP's (Alberta Culture & Community Spirit BDP Program (2007-2010).)

Dr. Fenner Stewart, University of Calgary Law School, Calgary



Dr. Fenner Stewart is an associate professor at the University of Calgary. He is an award-winning teacher and scholar. Dr. Stewart is the 2020 Dentons Canada LLP Research Fellow in Energy Law and Policy and also a 2020 Research Fellow in Energy and Environment at the School of Public Policy. Dr. Stewart has a Ph.D. in law from Osgoode Hall Law School (Toronto), where he was an adjunct professor for four years. He was also a Visiting Fellow at Columbia Law School. Dr. Stewart's research focus is on legal and political philosophy, the confluence of public and private law, and natural resource governance. He studies the challenges facing natural resource governance, including: decarbonization, federalism, obligations to indigenous populations, risk management, innovation and regulation, and public trust. His work addresses the public dimensions of natural resource regulation (such as energy federalism), the private dimensions (such as corporate responsibility), and the public-private dimensions (such as the roles of business, government, and civil society within risk governance networks). Topics from his recent publications and current research include: carbon pricing in Canada; jurisdictional disputes over the regulation of natural resource issues; environmental risk management and energy innovation; and risk governance networks and extractive industries. Dr. Stewart has taught Business Associations, the Dentons' International Energy Law Study Tour, and Oil and Gas Law in the JD program, as well as an LLM seminar in advanced jurisprudence and legal philosophy.

Dr. Carol Liao is an Assistant Professor at the Peter A. Allard School of Law and Director of the Centre for Business Law. She is also the UBC Sauder Distinguished Scholar of the Peter P. Dhillon Centre for Business Ethics, UBC Sauder School of Business. An award-winning teacher and widely published scholar, Dr. Liao is the co-author of *Business Organizations: Practice, Theory, and Emerging Challenges*, and is a contributing author to a number of groundbreaking new books in corporate sustainability: *The Cambridge Handbook for Corporate Law, Corporate Governance, and Sustainability*; *The Cambridge Handbook for Social Enterprise Law*; and *Creating Corporate Sustainability: Gender as an Agent for Change*. Dr. Liao is a past Bertram Scholar of the Institute of Corporate Directors and a former senior associate in the New York Mergers and Acquisitions Group of Shearman & Sterling LLP, a global law firm. She is a steering committee member of the Themis International Network of Female Business Scholars, and is currently co-editing a collection on sustainable business models with Dr. Beate Sjøfjell of the University of Oslo and Dr. Aikaterini Argyrou of Utrecht University. She has authored over 20 articles and book chapters and given over 50 talks around the world on business law and corporate sustainability. Her work has been cited in multiple media sources including *The Globe and Mail*, *CBC*, *Financial Post*, *The Tyee*, *Director Journal*, and *Business in Vancouver*.

Chief Ken Cameron, Saulteau First Nations, Moberly Lake



Chief Ken Cameron was born and raised at Moberly Lake in the Peace River / Treaty 8 Region of Northeast BC. He is a fluent Cree speaker and has a deep knowledge of Saulteau culture, the natural landscape, and business and community relations, including the relationships between indigenous peoples and the upstream natural gas, metallurgical coal, forestry, and wind and hydroelectric sectors. As a young man, Ken lived through the construction of the WAC Bennett Dam and experienced the impacts of that project on his community. Later, he was part of the construction team that built the Peace Canyon Dam. Ken has also worked as a hunting guide and horse wrangler, a commercial fisherman, a professional musician, and he is an award-winning artist and carver. For most of his professional life he and his wife Jeanette were the owner-operators of Deep Basin Energy Services - a successful pipeline construction company working in BC and Alberta with over 100 indigenous and non-indigenous employees. Ken retired from business and was elected Chief in April 2017. He has been leading a number of important new initiatives in the business, environmental, regulatory and community sectors, including the financing and construction of a community-owned 30MW windfarm project. In these and other ways Cameron is committed to improving the lives of the people in his community and in neighboring communities.

Tabatha is also an active member on the board of Young Peoples Theatre in Toronto and the Canadian advisory group to UN Women "promoting women's economic empowerment through responsible business in G7 countries".

Professor Cynthia Williams, Osgoode Hall Law School, Toronto



Cynthia Williams (Osler Chair in Business Law, Osgoode Hall Law School, York University, Toronto, Canada, and Professor of U.S. Corporate and Securities Law, the Vrije Universiteit, Amsterdam)

Professor Cynthia Williams joined Osgoode Hall Law School on July 1, 2013 as the Osler Chair in Business Law, a position she also held from 2007 to 2009; and was appointed to a part-time position as Professor of U.S. Corporate Law and Securities at the Vrije Universiteit (VU), Amsterdam in April of 2017. Before coming to Osgoode, she was a member of the faculty at the University of Illinois College of Law and, prior to that, she practised law at Cravath, Swaine & Moore in New York City. She writes in the areas of securities law, corporate law, corporate responsibility, comparative corporate governance, and regulatory theory, often in interdisciplinary collaborations with professors in anthropology, economic sociology, and organizational psychology. Her work has been published in the Georgetown Law Journal, the Harvard Law Review, the Journal of Corporation Law, Theoretical Inquiries in Law, the University of New South Wales Law Journal, the Virginia Law Review, the Academy of Management Review, the Corporate Governance International Review, and the Journal of Organizational Behavior, among others. Professor Williams also engages in policy work through her board membership in the Climate Bonds Initiative, a London-based NGO creating a new asset class, Climate Bonds, to finance the transition to a low-carbon economy; the Commonwealth Climate and Law Initiative, part of the Oxford Sustainable Finance Programme, which is evaluating directors' and trustees' legal obligations to consider climate change risk in companies' strategies and securities disclosure; and was the principal author of a petition submitted to the U.S. Securities and Exchange Commission in October, 2018, asking the SEC to engage in rule-making to require greater sustainability (environmental, social, and governance) disclosure.

Arlene Strom, Chief Legal Officer and General Counsel, Suncor, Calgary



Arlene Strom has been with Suncor Energy for 16 years. Since January 2019, Arlene has been in the role of Chief Legal Officer & General Counsel for Suncor. Externally, she has provided training on governance, responsible investing, and business ethics to accountants, pension trustees, board directors, and investment and governance professionals, and lectures on social finance to undergraduate and graduate students.

She currently serves on the boards of Canadian Business for Social Responsibility and the UBC Staff Pension Plan (\$1.8 bil AUM), as well as the governance committee at BlueShore Financial and faculty of Directors College.

Christie has more than two decades of diverse board experience, having served as a director of a charity, several cooperatives, numerous non-profits, two university senates, and several private companies ranging from startup phase to \$100 million in annual revenue.
