The successful applicant will:

- Teach the equivalent of six courses in a twelve-month period, at least two of which will be in the LLMCL program. Some teaching will take place during the May August summer term.

- Some of the teaching load may include developing new courses in our distance learning program, and teaching in the distance learning program.
