### COURSE DESCRIPTION

Advanced Legal Research will provide students with the ability to locate and update relevant case law, legislation and commentaries on specific topics. The course is designed to provide students with real, practical and substantial research skills used in legal practice, and will provide students with confidence as they undertake research for course work or begin their articles. Training will be provided on researching the law in British Columbia and Canada. The course will also touch on international law, as well as foreign jurisdictions such as the United Kingdom and the United States.

Students will have an opportunity to synthesize information gained through legal research into written documents commonly used in legal practice, particularly during articles. The emphasis will be on drafting legal research memoranda and translating research into pleadings and written submissions. Each class will have a research component, in which students will be introduced to specific research resources and methods; and a writing component, in which students will learn how to translate research into legal writing outputs. The overall learning experience will include reading assignments, individual and group exercises, and written assignments. Lecture slides, recordings, and additional materials to assist in exercises will be provided for each class.

### LEARNING OUTCOMES

Upon completing this course, students will be able to:

- Research and update relevant case law, legislation and commentaries on specific topics in British Columbia and Canada;
- Research and update relevant case law, legislation, treaties, commentaries on specific topics in international law;
- Research and update relevant case law, legislation, and commentaries on specific topics in various foreign law jurisdictions, including the United Kingdom, the United States, and the European Union;
- Draft advanced written legal research memoranda with confidence and consistency; and
- Understand how to structure and translate legal research into legal memoranda, pleadings, and written submissions.

#### Research Assignments – 85%

Students are required to complete two (2) written take home assignments. Students must work individually on these assignments and meet assignment deadlines. In addition to content, students will be assessed on their research process, analysis, legal citation, and overall quality of their written work.

**Assignment 1** will graded on a Pass/Fail basis where the passing threshold is 65%. Regardless of the passing threshold, only a Pass or Fail grade will be assigned. If a student fails the assignment, **2%** will be deducted from their final mark in the course.

Assignment 2 will be worth 85% of each student's total mark, subject to Assignment 1.
