Leonard became a member of the Queen's Privy Council in 1976, was made a Member of the Order of Canada in 1999, and was awarded the Order of British Columbia in 2014. He received an honorary doctorate from Thompson Rivers University, as well as Queen Elizabeth II Silver, Golden and Diamond Jubilee Medals.
