If Option B is Selected:

LSLAP will not receive access to students' law school grades. A student who only applies to LSLAP and does not apply to any other Allard Law experiential learning program that collects grades will not have their law school grades collected or distributed to any experiential learning programs.

4. Program Schedule Overview

Students are responsible for managing their time and are expected to be fully engaged while participating in the program. Students should plan their affairs accordingly given the program schedule below:

Our program runs from May – August, with a full week long training program sometime in May, it is scheduled as part of the larger LSLAP summer program. We meet at least once a week, the date and time of our meetings is based on student availability. At these weekly meetings we discuss files students are working on and how to move them forward, as well as go over substantive information.

ADDITIONAL INFORMATION RE: GRADES COLLECTION AND DISTRIBUTION

1. Do I need to include my law school grades in my application?

All clinics have their own application requirements that are set out in their fact sheets. Students should carefully review each program's fact sheet to determine whether law school grades are required to apply.

- 2. I applied to a program that will review law school grades that are available up until the application deadline. (A) Do I need to provide an updated transcript once my April 2023 grades are available? (B) Who will get access to my grades?
 - (A) Students do not need to provide updated transcripts. These programs will not consider your April 2023 grades.
 - (B) The only programs that will have access to your grades are the programs to which you apply. The only grades that they will have access to are the grades that you include in your application package.
- 3. I did not apply for a program that requires grades. Who will get access to my grades?



If you did <u>NOT</u> apply to any experiential learning program that requires grades, your grades will not be provided to any experiential learning programs.

4. I have concerns about providing my law school grades to an experiential learning program. What should I do?

Grades are only collected for the purpose of recruitment for Allard Law's experiential learning programs. If you have any concerns about the collection of your grades, please contact <u>Barbara Wang</u>, Manager, Student Affairs, <u>before</u> the application deadline.
