If Option B is Selected:

Students must follow the same instructions as in Option A. Additionally, students should note the following:



- Allard Law Student Affairs will provide a grade report of students' 2022-2023 grades (i.e. including April 2023 grades), to Allard Law experiential learning programs that require access to these grades as part of their recruitment process (including upperyear moot programs).
- Information regarding students' Allard Law grades is collected under the authority of section 26(c) of the *Freedom of Information and Protection of Privacy Act* (FIPPA).
 Students' grades will be used for the sole purpose of recruitment for Allard Law's experiential learning programs.
- For greater clarity, if you apply for the UBC Innocence Project, your 2022-2023 grades will be provided to the UBC Innocence Project and <u>all</u> other experiential learning programs that review April 2023 grades as part of their recruitment process (regardless of whether you applied to those particular programs).
- Please consult the Additional Information re: Grades Collection and Distribution below for additional information on this process. Questions about the collection of student grades should be directed <u>before</u> the application deadline to <u>Barbara Wang</u>, Manager, Student Affairs.

If Option C is Selected:

The UBC Innocence Project will not receive access to students' law school grades. A student who <u>only</u> applies to The UBC Innocence Project and does not apply to any other Allard Law experiential learning program that collects grades (including upper-year moot programs), will not have their law school grades collected or distributed to any experiential learning programs.

5. Program Schedule Overview

Students are responsible for managing their time and are expected to be fully engaged while participating in the program. Students should plan their affairs accordingly given the program schedule below:

The program is a full year program and we have real clients who need services throughout the year. Many students have successfully balanced other experiential learning programs with the UBC IP but the work cannot be shifted from one term to another. As with all legal cases, the work will ebb and flow; some weeks will be busy and others will be slow depending on the case assigned and the nature of the work required on the case. Students have input into both of these factors so should be able to balance the casework with other commitments if their academic year is well-planned.

ADDITIONAL INFORMATION RE: GRADES COLLECTION AND DISTRIBUTION

1. Do I need to include my law school grades in my application?

All clinics and externships have their own application requirements that are set out in their fact sheets. Students should carefully review each program's fact sheet to determine whether law school grades are required to apply.

- 2. I applied to a program that will review law school grades that are available up until the application deadline, but does <u>NOT</u> require April 2023 grades. (A) Do I need to provide an updated transcript once my April 2023 grades are available? (B) Who will get access to my grades?
 - (A) Students do not need to provide updated transcripts. These programs will not consider your April 2023 grades.
 - (B) The only programs that will have access to your grades are the programs to which you apply. The only grades that they will have access to are the grades that you include in your application package.
- 3. I applied to a program that requires April 2023 grades. (A) Do I need to provide an updated transcript once my April 2023 grades are available? (B) Who will get access to my grades?
 - (A) Students do not need to provide updated transcripts. Student Affairs will provide April 2023 grades to all Allard Law experiential learning programs that require access to these grades as part of their recruitment process.



(B) Programs that you have applied to will receive, as part of your application package, your law school grades that are available up until the application deadline. They will also receive your April 2023 grades in the form of a master grade report containing the 2022-2023 grades of all students that have applied to an experiential learning program requiring April 2023 grades.

Additionally, all other experiential learning programs (i.e. clinics, externships, upper-year moots) that require April 2023 grades will have access to your 2022-2023 grades. Allard Law is currently unable to provide clinics and externships with tailored grade reports. Therefore, <u>all</u> experiential learning programs that require April 2023 grades will receive the same master grade report.

4. I did not apply for a program that requires grades. Who will get access to my grades?

If you did <u>NOT</u> apply to any experiential learning program that requires grades, your grades will not be provided to any experiential learning programs.

5. I have concerns about providing my law school grades to an experiential learning program. What should I do?

Grades are only collected for the purpose of recruitment for Allard Law's experiential learning programs. If you have any concerns about the collection of your grades, please contact Barbara Wang, Manager Student Affairs, **before** the application deadline.
