

WSÁNEĆ LAW FIELD COURSE 2023-2024 Application Fact Sheet

Note: This document provides information regarding the application process for a 2023-2024 position with the WSÁNEĆ Law Field Course. 1. Application Package

Students must include the following materials in their application package:

- (a) 🗆 Resume
- (b)
 Cover Letter
- (c) 🛛 Completion of the Mandatory Experiential Application Survey
- (d) □ Contact information for 2 references to be included in the Mandatory Experiential Application Survey
- (e) ⊠ Other: The WSÁNEĆ Law Field Course Application form together with a one-page statement of interest indicating why you are interested in the course. The application form can be found on the <u>Allard Law Clinics and Externships webpage</u>.

Please see the <u>Allard Law Clinics and Externships webpage</u> for additional guidance on preparing these materials. All application package materials should be submitted via <u>ACE</u>. All experiential opportunities are labelled "ExL 2023 - 2024: Clinic Name" on ACE.

2. Grades

The WSÁNEĆ Law Field Course will review the following grades in their recruitment process:

- (a) □ Law school grades that are available up to the date of the Application Deadline will be reviewed
- (b) □ Law school grades that are available up to the date of the Application Deadline <u>AND</u> April 2023 grades will be reviewed
- (c) \boxtimes Law school grades will NOT be reviewed

If Option A is Selected:

2L and 3L students must include a copy of their Allard Law Transcript in their application package.

- i. \Box The Transcript must be an official copy.

1L students must include a copy of their December Grade Report in their Application Package.

If Option B is Selected:



Students must follow the same instructions as in Option A. Additionally, students should note the following:

- Allard Law Student Affairs will provide a grade report of students' 2022-2023 grades (i.e. including April 2023 grades), to Allard Law experiential learning programs that require access to these grades as part of their recruitment process (including upperyear moot programs).
- Information regarding students' Allard Law grades is collected under the authority of section 26(c) of the *Freedom of Information and Protection of Privacy Act* (FIPPA). Students' grades will be used for the sole purpose of recruitment for Allard Law's experiential learning programs.
- For greater clarity, if you apply for the WSÁNEĆ Law Field Course, your 2022-2023 grades will be provided to the WSÁNEĆ Law Field Course and <u>all</u> other experiential learning programs that review April 2023 grades as part of their recruitment process (regardless of whether you applied to those particular programs).
- Please consult the Additional Information re: Grades Collection and Distribution below for additional information on this process. Questions about the collection of student grades should be directed <u>before</u> the application deadline to <u>Barbara Wang</u>, Manager, Student Affairs.

If Option C is Selected:

The WSÁNEĆ Law Field Course will not receive access to students' law school grades. A student who <u>only</u> applies to the WSÁNEĆ Law Field Course and does not apply to any other Allard Law experiential learning program that collects grades (including upper-year moot programs), will not have their law school grades collected or distributed to any experiential learning programs.

3. Interviews

 □ The WSÁNEĆ Law Field Course will conduct interviews as part of the recruitment process. Only short-listed applicants will be contacted.
- b. □ The WSÁNEĆ Law Field Course will not conduct interviews as part of the recruitment process.
- c. ⊠ The WSÁNEĆ Law Field Course may conduct interviews as-needed as part of the recruitment process.

4. Compatibility with Upper-Year Moot Programs

- (a) □ Students may participate in a moot and the WSÁNEĆ Law Field Course in the same academic year.
- (b) ⊠ Students may <u>not</u> participate in a moot and the WSÁNEĆ Law Field Course in the same academic year. However, students may participate in the Kawaskimhon Moot in Term 2.

NOTE: In addition to the above notations, students cannot take any other courses (including other experiential learning opportunities) during their WSÁNEĆ Law Field Course term.

5. Program Schedule Overview

Students are responsible for managing their time and are expected to be fully engaged while participating in the program. Students should plan their affairs accordingly given the program schedule below:

Students should note that the course is on Vancouver Island. The month of September is devoted to land-based learning, and students should expect at least 6-hours of class contact time per day, Monday through Friday, during that time. Appropriate clothing and camping gear is required (reach out if this is an issue). The following 8 weeks is devoted to community projects and students must commit to a minimum of 30 hours per week of community-based project work, as well as 1 day per week for guests and debriefing sessions. The last week is 6-hour class times for presentations..

ADDITIONAL INFORMATION RE: GRADES COLLECTION AND DISTRIBUTION

1. Do I need to include my law school grades in my application?

All clinics and externships have their own application requirements that are set out in their fact sheets. Students should carefully review each program's fact sheet to determine whether law school grades are required to apply.

I applied to a program that will review law school grades that are available up until the application deadline, but does <u>NOT</u> require April 2023 grades. (A) Do I need to provide an updated transcript once my April 2023 grades are available? (B) Who will get access to my grades?

(A) Students do not need to provide updated transcripts. These programs will not consider your April 2023 grades.



(B) The only programs that will have access to your grades are the programs to which you apply. The only grades that they will have access to are the grades that you include in your application package.

3. I applied to a program that requires April 2023 grades. (A) Do I need to provide an updated transcript once my April 2023 grades are available? (B) Who will get access to my grades?

- (A) Students do not need to provide updated transcripts. Student Affairs will provide April 2023 grades to all Allard Law experiential learning programs that require access to these grades as part of their recruitment process.
- (B) Programs that you have applied to will receive, as part of your application package, your law school grades that are available up until the application deadline. They will also receive your April 2023 grades in the form of a master grade report containing the 2022-2023 grades of all students that have applied to an experiential learning program requiring April 2023 grades.

Additionally, all other experiential learning programs (i.e. clinics, externships, upperyear moots) that require April 2023 grades will have access to your 2022-2023 grades. Allard Law is currently unable to provide clinics and externships with tailored grade reports. Therefore, <u>all</u> experiential learning programs that require April 2023 grades will receive the same master grade report.

4. I did not apply for a program that requires grades. Who will get access to my grades?

If you did <u>NOT</u> apply to any experiential learning program that requires grades, your grades will not be provided to any experiential learning programs.

5. I have concerns about providing my law school grades to an experiential learning program. What should I do?

Grades are only collected for the purpose of recruitment for Allard Law's experiential learning programs. If you have any concerns about the collection of your grades, please contact <u>Barbara Wang</u>, Manager, Student Affairs, <u>before</u> the application deadline.
