### Assessment Details & Mark Allocations

#### **Indigenous Settler Legal Relations Assessment:**

Critical Self-reflection – 20% of final grade.

Final Exam – 60% of final grade.

Participation – 20% of final grade (Details TBC).

#### **Legal Research & Writing Assessment:**

In-Class Exam – worth 50% of total mark in the course.

Assignment – worth 50% of total mark in the course.

#### **Advocacy Factum & Moot Assessment:**

This is a pass/fail assignment. Students will work in pairs and be marked primarily on their assigned issue, but consideration will also be given to the joint areas of the factum. Where a student receives a failing mark for their factum, they must meet with the professor and then redraft the relevant section of the factum. The student's redrafted section is due ten days after the factum is returned to the class. If the redrafted factum is not of passing quality, the student will continue to work with their professor and resubmit their factum until a passing mark is achieved. To receive a pass in the course, students are required to complete and pass the factum and moot components. Students who are unable to attend

#### **Introduction to Public Law & the Charter**

Participation is a component of the mark in this course. The final exam is worth 100% of the final grade subject to a deduction of 5 marks if a student fails participation. For example, 75/100 Exam Score - Failed Participation (5 Marks) = 70 Final Grade. The format of the participation assessment varies by instructor.

#### **Criminal Law & Procedure**

The final grade is subject to a deduction of 5 marks if a student fails participation (e.g. 75/100 Final Grade – Failed Participation (5 Marks) = 70 Final Grade). The format of the participation assessment varies by instructor.

#### **December Practice Exams in Full-Year courses:**

If the December Practice Exam Mark in a full-year course is less than or equal to the April Exam Mark, then the April Exam mark equals the Overall Exam Mark. Otherwise, if the December Practice Exam Mark is greater than the April Exam Mark, then 25% of the December Practice Exam Mark plus 75% of the April Exam Mark equals the Overall Exam Mark.
